

ANNUAL REPORT 1 NOVEMBER 2019 TO 31 OCTOBER 2020

VIEW FROM THE CHAIR – REV LIZ O'RYAN

Welcome to the Annual General Meeting of the East Lothian Foodbank and to the presentation of our Annual Report. I'd like to begin by thanking Lucy, Penny and Mark for putting the information together for this meeting.

Well, what a year it has been! I know everyone says that – but it really has been a tough one. Little did I know, when I took over the Chair of the Foodbank just 12 months ago, how the world would change. No-one could have predicted the devastating effects this pandemic has wrought. Now face masks, national restrictions, widespread unemployment, shocking figures of premature deaths, and rising mental health issues are part of the natural landscape. And sadly, this is not happening far away, or even to a minority – I expect none of us have remained unaffected by what has happened.

All of these things, of course, have had a huge impact upon our service. The Trussell Trust figures make for grim reading. A record 1.9 million food parcels have been given out over the past year, 700,000 of them being for children. In Scotland 237,000 parcels have been given out. Over the past five years foodbank use has increased 74%. Our resource has never been more needed. Yet it is heartening to see that generosity has also never been higher. The Trussell Trust has raised £1million pounds over the past year, and you will see from our accounts later, that we too are in a healthy financial position. But that does not mean we are complacent. The Trussell Trust has pledged to use their money to work for a 'Hunger Free Future' – a time when foodbanks will be no longer be needed. Their aims chime with our own in East Lothian, as the Board has plans which include sharing our funds with others who are working to alleviate poverty, as well as implementing signposting services and structures which will help people climb out of the poverty trap.

This year past has necessarily been a year of incredible hard work. The Board are proud that the Foodbank continued its service throughout this time. That was no mean feat, and was and continues to be completely due to the commitment and dedication of the volunteers and staff. I would like to thank you all, whether you have donated, sorted, cleaned, humped bags and tins, delivered, written reports, inputted data — whatever it is you have done — if you are part of our Foodbank family, I thank you from the bottom of my heart. Children and adults have gone to bed fed because of you.

The year was also one of change. Peter Dicker, Paul Chapple and Candace Higgins have now moved on from the Foodbank (although Peter and Paul are now back volunteering) and I would like to take this opportunity to thank each of them for their work and commitment. Their contribution is much appreciated, and we wish them all well for the future. Lucy Daniels, meanwhile has kept the wheels turning through the changes, and I would like to especially thank her – her constant steadiness and calm have been invaluable. The Foodbank is now advertising for a new team to take us into 2021, and already the response has been good. Our next year promises an exciting one of opportunity.

I would also like to thank the members of the Board, who have worked many, many extra hours to ensure the Foodbank's work continues unabated. The challenges of the last year did not make this easy, but by working as a team the difficulties we encountered were overcome. During this coming year we hope to recruit new members to the Board and indeed would be interested in anyone who might feel the push to come and join us – it is fun, believe me!

So into 2021 we go. Our strategy will continue to have a passion for helping others and tackling inequality, to be compassionate in our working practices and innovative in identifying what needs to be done and ways to do it, and continue to be committed to empowering our community so that change is brought about. We hope you will feel able to walk beside us, and continue to support us in the different ways possible.

OUR AIMS AND ACTIVITIES

East Lothian Foodbank is a Scottish Incorporated Charitable Organisation (SCIO), registered on 30 October 2012 (registered number SC043523). We are affiliated to UK poverty and hunger charity The Trussell Trust. The foodbank was set up as a response to local need and we have been the last resort for thousands of local people since opening.


Our purpose is the prevention or relief of poverty and in East Lothian by providing emergency food supplies to individuals in need and / or charities or other organisations working to prevent or relieve poverty; to provide services to people who have need of them by reason of their age, ill-health, disability, financial hardship or other disadvantage.

We help any local person who is referred to us. We treat all clients without judgement and with respect, compassion, justice and dignity.

We want to see a future where there is no need for foodbanks, where everyone has enough money coming in to cover the cost of essentials like food. No-one should go hungry because they don't have enough money.

Our main Activities are:

Collection of donations of food and non-food essentials for distribution to people in need. Thank you to everybody who has donated food and non-food essentials, we are so very grateful to you all. The weight of donations this year totalled 74,563kgs. This compares to last year's total of 64,341kgs, an increase of 15.9%. These donations have broken down as per the chart below.



Emergency food deliveries. We delivered a total of 2,939 food parcels across the county, that is nearly 57 every week. This compares to 2,604 last year, an increase of 12.9%. We fed a total of 7,060 (last year 5,912) people. Of these 2,827 (last year 2,243) were under the age of 16. (This includes multiple referrals.) We gave out a total of 69,503kgs (last year 47,403 kg), a 46% increase. Of this amount 62,597kgs was direct to service users.

Alongside the standard food parcels, we also gave out Jingle Bags, which are essentially a Christmas dinner in a parcel. In December 2019 we gave out 241 (compared to 165 in 2018) with another 219 (181) being made up for partner organisations who distributed them within the community

Gold standard client service. We aim to offer choice and dignity, fresh food and also non-food essentials.

Partnerships. We work with community groups and donate food to support holiday lunch clubs, community larders, breakfast clubs and similar initiatives which address poverty and hunger.

"More than Food" initiatives. We have initiated cookery classes in previous years and have funded the Fa'Side Fridge, which offers "food, fun and friendship" in Tranent.

Raising Awareness. We know that it takes more than food to end hunger and, as part of the Trussell Trust network, we can bring together our experiences and those of our community to challenge the structural economic issues that lock people in poverty and join the campaign for change to end hunger and poverty in the UK.

FINANCIAL REVIEW

Reserves Policy

The bank balance at the 31st October 2020 amounts to £191,901 of which £16,496 is Restricted Funds; thus, the level of reserves held at the Year End 31st October 2020 amounts to £175,406. Of this reserve amount £80,000 is held in an interest-bearing savings account with The Skipton Building Society and covers funds set aside for Designated purposes. This leaves us with unrestricted funds totalling £95,406.

The current target minimum for our unrestricted general funds reserve is equal to six months' average operating costs, including all recurring, predictable, and unavoidable expenses. Based upon total payments in the accounts to 31 October 2020 our reserves target is therefore £44,900.

You can therefore see that we have significantly higher funds than our minimum target, which is why the Trustees are working hard on plans and strategies to make the best use of our positive financial situation for the wider good of the community.

Our current rented premises are on a short-term six-month lease agreement with East Lothian Council. The Council's future planning proposals for Tranent Town Centre show our current premises as earmarked at some stage for demolition. Subsequently our Trustees are aware that relocation will at some indeterminate time be inevitable and therefore a large part of the designated fund held with the Skipton Building Society may be called upon at very short notice. In the meantime, we have a responsibility to maintain the premises in good repair, ensure they are well equipped, and that they remain fit for purpose at all times for both staff and volunteers so fulfilling Health and safety requirements.

Demand for East Lothian Foodbank core services continues to grow. We anticipate that the pandemic response and recovery will last a long time, and that demand will not diminish in the short term. We will therefore need our resources to see us through this.


Plans are in place to meet our growing need to relieve poverty and hunger in the area. These include the recruitment of additional staff appointments and the offer of funds / grants to other local charities and organisations that are working to prevent or relieve poverty (see later in the report for more details).

Finally, in the short term, we must ensure that we have the ability and facility to instantly provide finance for any shortfall in food items. These items comprise both the content of perishable and non-perishable food parcels containing the three days' supply of nutritionally balanced food for our clients.

Receipts


The main story for this last year is how generous the public and businesses have been; all pulling together during the harshest of times during the lock down and onwards. We would like to take this opportunity to thank everybody who has donated to us this year and are sorry that the volumes prevent us from thanking you all personally. With the activities of foodbanks regularly making the news our donations more than quadrupled over the previous year (from £24,585 to £114,718), rising significantly from March 2020 and remaining at a higher level than seen pre-pandemic. On top of this, the foodbank was chosen as the nominated charity for the Scottish Ladies Golf Open, which was held at Archerfield in September. This resulted

in a one-off amount of £27,000 being donated. At the same time, we received eight Restricted grants totalling £45,211, mainly to assist us during the Covid-19 pandemic (see the bottom left of the Cost Report on page 7). This compares to £6,459 the previous year. These grants have allowed us to offer each client extra food and a provision of fresh food.



Payments

Ironically, all these funds were received just at the time when we couldn't run any services other than the core parcel delivery. Grant monies received have been used in purchasing fresh food, fruit and vegetables to supplement our normal parcels. Total expenses for the year were £89,757 (last year £58,506).



As mentioned earlier we are lucky to have a surplus of reserves at the moment. There are no signs that the pandemic will be going away so we will be unable to return to our partnership work or "more than food" initiatives in the short term. The trustees have therefore agreed as part of our future strategy to offer funds / grants to other local charities and organisations that are working to prevent or relieve poverty. - 5. Identifying unmet need in relation to food poverty and the root causes of food poverty for residents of East Lothian, and developing and delivering creative, effective, and sustainable additional services in response
- 6. Building strong partnerships with agencies and organisations across East Lothian tackling food poverty and the causes of food poverty, and taking a lead to coordinate and support effective local responses

- We have a reliable supply of core emergency food items and other essentials at all times, through donation and by other means, and we can respond to all requests even at times of high demand
- We have a clear understanding of need for our crisis service and have increased access to this service for those we are currently not engaging across the county either directly; via referral agencies; or by supporting more local community partners through the provision of food and essential items for more local distribution
- Fresh food provision for all service users is set on a sustainable footing, through generating additional sustainable funding for fresh food and working with suppliers to access reliable supplies of fresh food for crisis service users and others
- We monitor of our service with service users, referral agents, and other partners to understand and evidence the quality of our crisis service

2 – Support long term change for people living in poverty through 'More Than Food' projects

- We have identified opportunities to reduce demand on our crisis service and have developed, achieved funding for and delivered interventions that contribute to the drivers of food poverty
- We have mapped and collated information on services and local projects of value to service users, and be able to provide accurate information on services and projects in an accessible format to service users, referral partners, and others as required
- Our staff and volunteers are aware of other services and projects, and we have put in place effective signposting protocols for staff and volunteers to use
- We have in place formal referral processes with services and local partners where appropriate and we are making connections for service users and partners whenever we can

3 – Advocacy for change

- We act to raise awareness in our communities about food poverty and it's causes
- We take a lead on food poverty issues by participating in local and national policy consultation, contributing to local strategy development and by contributing to the ongoing campaign and influencing work of the Trussell Trust

4 – Strong and sustainable organisation

- Good governance Our Board is experienced and knowledgeable and has the skills required to govern and grow an essential service during challenging times. We have in place a Strategy and Business Plan for the organisation, supported by strong governance processes and procedures and we work closely and openly with our staff, volunteers and members to deliver our strategy.
- staff and volunteers We have the right staff in the right roles, our staff and volunteers are well supported, and everyone is able to contribute and their contributions valued
- Income, funding, sustainability The organisation is financially stable and sustainable for the long term. We have in place clear plans both for raising income and for ensuring we allocate donated funds where they can make the most impact.
- Facility and operations Our facility meets the needs of our staff, volunteers and clients and we are equipped to deliver a Gold Standard crisis service and impactful additional services
